Attached you will find a list of **project-based Section 8 apartment communities** and one other agency, Community Action of Greater Indianapolis, that also serves Hamilton, Boone, and Tipton County with the Housing Choice Voucher (HCV) program. You will need to contact each to verify if they are accepting applications and how to apply.

Another form of affordable rental housing is called the **Low-Income Rental Housing Tax Credit** (LIHTC) program built under IRS rules known as **Section 42**. These apartments are for families with income, and they have a minimum/maximum annual income range to be eligible and have a rent that must be paid monthly; these are not Section 8 where the families pay 30% of their monthly adjusted income. Hamilton County has several LIHTC properties:

Currently the Noblesville Housing Authority, serving Hamilton County, is not accepting applications for the Housing Choice Voucher (HCV) rent assistance program (family based "Section 8"). We only have funding for a maximum of 203 families per month and have very little turnover to issue to new families. You are welcome to check back with our office to see if we are accepting applications for the HCV program. The HCV program can help families pay rent in an apartment, single family home, or manufactured home of their choice following many regulations.
